# Conditions

for the use of the mark as illustrated [Baumuster geprüft]

This certificate is valid exclusively for the company named overleaf and the manufacturing site stated. Only the Test Centre is authorised to extend the approval to third parties.

The permission to use the illustrated mark applies only to such products which correspond to the approved type tested by the Test Centre and detailed overleaf.

All products for which the mark is used must bear the company's sign (sign of origin) in the form registered with the Test Centre. The TÜV mark and the company's sign must always be applied together to or in the same parts of the product, and if at all possible in the same manner and so as to be long-lasting and easily read.

The holder of the certificate is obliged to monitor the manufacturing of the products granted the mark continuously to ensure they match the TÜV testing regulations, and in particular to carry out the inspections laid down in the testing regulations or ordered by the Test Centre according to the rules.
